Ambulance cover

Call-out fees: will be paid for each attendance, including emergency treatment without transport to hospital.

You are covered for the uncapped costs associated with emergency ambulance transport services including on-the-spot emergency attendances, and up to \$5000 for non-emergency ambulance per person per calendar year, where the service is provided by a Bupa recognised ambulance service. The following ambulance services are recognised by Bupa: ACT Ambulance Service, Ambulance Service of NSW, Ambulance Victoria, Queensland Ambulance Service, South Australia Ambulance Service, St John Ambulance NT, St John Ambulance WA, and Ambulance Tasmania.
