## **Ambulance cover**

In Western Australia this policy provides:

**Non-emergency:** transport with a waiting period of 1 day, limited to \$5,000 per person per year.

**Call-out fees:** will not be paid.

You are covered for the uncapped costs associated with emergency ambulance transport services including on-the-spot emergency attendances, and up to \$5000 for non-emergency ambulance per person per calendar year (via air or road), where the service is provided by a Bupa recognised ambulance service.
