- 12 months for other pre-existing conditions
- 12 months for pregnancy and birth (obstetrics)
- 2 months for all other treatments

Frank Basic Accident Boost Hospital includes Private Emergency Department Attendance Benefit which covers 50% of the emergency department attendance/administration fee up to \$200 per person, yearly. This benefit is payable towards up-front attendance/administration fees charged by a private hospital upon presentation at an emergency department, which vary by private hospital. It is not payable on any fees where a Medicare benefit is claimable, such as medical, radiology or pathology charges. Members need to submit a paid invoice through the mobile app or by email to claim this benefit, therefore will incur an out-of-pocket cost upfront. Two month waiting period applies.

In South Australia this policy provides:

Emergency: Unlimited with no waiting period.

Call-out fees: will be paid for each attendance, including emergency treatment without transport to hospital.

Benefits for emergency transportations are available on hospital and selected eligible extras covers. To avoid unexpected out of pockets, we strongly recommend taking out a subscription to be covered Australia wide, regardless of your health insurance.
