The benefits paid for hospital treatment will depend on the type of cover you purchase and whether your fund has an agreement in place with the hospital in which you are treated. Under this policy, you may have to pay out-of-pocket costs above what you get from Medicare or your private health insurer. Before you go to hospital, you should ask your doctors, hospital and health insurer about any out-of-pocket costs that may apply to you.

The following payments may also apply for hospital admissions

Excess: You will have to pay an excess on admission. This is limited to a maximum of \$750 per person and \$1500 per policy per year.

Co-payments: No co-payments

The following waiting periods for hospital admissions apply to new or upgrading members

Waiting periods:

- 2 months for palliative care, rehabilitation and hospital psychiatric treatments, even if pre-existing
- 12 months for other pre-existing conditions
- 12 months for pregnancy and birth (obstetrics)
- 2 months for all other treatments

Other features of this hospital cover

Frank Basic Accident Boost Hospital includes Private Emergency Department Attendance Benefit which covers 50% of the emergency department attendance/administration fee up to \$200 per person, yearly. This benefit is payable towards up-front attendance/administration fees charged by a private hospital upon presentation at an emergency department, which vary by private hospital. It is not payable on any fees where a Medicare benefit is claimable, such as medical, radiology or pathology charges. Members need to submit a paid invoice through the mobile app or by email to claim this benefit, therefore will incur an out-of-pocket cost upfront. Two month waiting period applies.

Ambulance cover

Ambulance cover is provided by the State government for residents of Tasmania. This may include cover whilst interstate, except for South Australia and Queensland where no cover applies.
