Excess: You will have to pay an excess of \$250 per admission. This is limited to a maximum of \$250 per person per year.

Waiting periods:

- 2 months for palliative care, rehabilitation and hospital psychiatric treatments, even if pre-existing
- 12 months for other pre-existing conditions
- 2 months for all other treatments
